

## Process Server: By the Hague Convention and Courier

Fast and Legal International or European service of process and Subpoenas anywhere within Western and Eastern Europe (E.E.C. members or not), including the Russian federation. Our service of process is completed with confidentiality, integrity and immediately by qualified professionals in Civil and Commercial matters, for Judicial or extra-Judicial documents, we also serve subpoenas. Our services are compliant with Hague Service Convention of [1965](#) and Hague Evidence Convention of [1970](#), [E.E.C. regulations](#) and local rules of Civil procedure in non Hague Signatory's countries and always in conformity with Federal Laws.

We act as Special Process Servers for International Private Personal Service of Process and/or Subpoenas everywhere, in all cities (Hague and Non Hague). Registered Barristers-Solicitors and Authorized Process Servers by the Ministry of Justice. within the E.E.C.. Our [prices](#) depend on the kind of service and time to serve,: We can serve rush from 72 hrs or regular simple serve of 30 days, that is;

I. "**Direct Hague Central Authority submission and follow up**": This service consist of a fast and controlled manner to the use of the Central Authority of each Hague signatory Country it is based in the submission of a Summary translation by local Certified Translator along side an Attorney declaration of the Case's nature. These services includes;

1. Local Central Authority **Filing and Screening** for acceptance (Civil or Commercial).
2. Establish an **estimate** cost of translation if a summary is not possible.
3. **Follow up** of the local procedure in order to remove any obstacle and avoid any possible "Reject" from the Central Authority, such as correct address, form... .

II. "**Private Personal Service of Process**": This is a "hand to hand delivery", completed by European Barristers-Solicitors acting as international process servers; it is fast and reliable, requires no translation of documents and there is no exam of case's nature. The importance of this kind of service is that "can't be rejected" not by the "addressee" neither the "Central Authority". There is No lost of confidentiality and evidence of service is included: "Video", "Photography" or a "Reception Receipt" or "Waiver", addressee receives professional legal advise on International Procedure to follow. The result of service is a very complete Notarized "Affidavit of Service".

*Please note that because of our reputation, based on our impartiality and integrity of service, some Central Authorities will issue an [Affidavit](#) of service confirming our International Private Service of Process or will even use our services when they fail to serve.*

III. "**Local Judicial Officers Service of Process**", It is the same as above but completed by a Judicial Officer instead of a Barrister Solicitor. The result is also an Affidavit in English, authenticated by the either by the Consular representative or by the Central Authority . Main advantage of using a "Judicial Officer" is that, in some countries, a "Public Record of Service" is kept and is available for verification when "Exequatur" is needed in the future. If no International repercussion of the case exist and you do not need enforcement abroad then other less sophisticated services or process are available.

IV. **"Special Process Server"** We accept "ipso facto" and "ipso iure" all foreign Court of Justice mandates to serve process; **"Emergency or rush service of process", "difficult to serve cases", "Difficult locations", "Judicial or Extra-Judicial" cases:** We serve, with evidence and witnesses anywhere within Eastern or Western Europe and the Ex-USSR. This service is recommended for highly confidential Arbitration cases.

V. **"Legal Courier"** as per Article 10 - a of the Hague Convention not recommended for Countries not part of the Hague Convention or those that oppose to Article 10 even when reciprocity exist.

VI. **"Courtesy Service" or "Parallel Service"** If you have ordered legal process service to the "Central Authority", "Mail" or "Judicial Officer" or even to a "Private Process Server" as a measure of International litigation security you must complete a second parallel service. Indeed, serving another set of documents is a preventive measure that guarantees reception and highly protect you against during a "Motion to Quash". We complete International Private Personal Service of Process as Barristers-Solicitors and reinforce it with a parallel service by any of the following methods: mail, Judicial Officer or the Central Authority. This service is highly desirable in application of Article 5 of the Hague Convention or when the Central Authority fails to serve and prior their Authorization.

VII. **"Private Subpoena Service"**: Either as "Parallel Service" to a "Letter of Request" sent to the "Central Authority" or if in application of "Common law Court acceptable principles" to accelerate a process and gain time, and which will be confirmed after-wards either by the Central Authority or Consular services.

VIII **"Depositions"** Most foreign Central Authorities will not accept to take a Deposition or Evidence in "Pre-Trial" Cases, Arbitration or "Extra-Judicial". The Consular depositions can not be held outside the Consular premises and Consular Agents will not travel to remote location. We take Video depositions and evidence everywhere and for everything! Our travel to deponent or to the evidence! We propose also telephone conference service, Video taped depositions or by Written Questionnaire.

IX. **Registered Agents of Contracts** within the European Economical Community.

X. **Quash Expertise** We act for International Service of Process not compliant with International Private law or in violation of local rules of procedure, even if case was completed under the Hague Convention. Our champ of excellence is quash of service of process not completed by legal professionals such as Barrister-Solicitors or Judicial Officers i.e. Service by Private Investigators.

XI. **"Extraordinary Service of Process"** Because our reputation often we are required to complete services in those countries we do not serve normally. We service North America, Europe, western and eastern countries including the Russian federation, and exceptionally countries in political difficulties.

**In summary;** We serve Hague Convention's signatory countries by "Direct Hague Central Authority Remittance" (Art. 3), when the Central Authority fails (Art. 5) and by "Alternative Channels" (Art. 10); Indeed we serve in all Jurisdictions and specially in those jurisdictions that have not oppose to the application of Article 10 a, b and c. Please note we also serve in those that opposed to Article 10 prior fulfilling the condition of official failure and by authorization of the Central Authority, as per Article 5 and applying directly Art. 10.

**In all cases the result is an Affidavit of Service in English language authenticated by the Consular representative, guaranteeing our personal presence and backup in any Court of Justice.**
